STUDENT SCHOLARSHIP POLICY

At Pragati Engineering College, our core belief revolves around acknowledging and motivating academic brilliance within our student community. Our dedicated Student Merit Scholarship Policy is designed to commend exceptional achievements, foster a culture of perpetual learning, and extend financial assistance to deserving students.

The policy endeavors to offer much-needed financial support to those students who demonstrate exceptional talent but may face financial constraints. The Student Merit Scholarship Policy sets clear guidelines for eligibility, ensuring that deserving candidates have a fair chance of availing themselves of this opportunity. Additionally, it outlines the various scholarship types available, catering to different forms of excellence, such as academic achievements and subject-specific proficiency.

1. AWARDING SCHOLARSHIPS, PRIZES AND MEDALS TO STUDENTS

- 1.1. In order to financially assist
 - (a) meritorious students coming from weaker economic background,
 - (b) girl students and

(c) Scheduled Castes (SC), Scheduled Tribes (ST) and Other Backward Caste(OBC) students,

the Institute may award

- (i) Scholarships,
- (ii) Tuition Waivers (Freeships),
- (iii) Book and other Grants,

and any other facilities from its own funds as per government policies and guidelines applicable at the time of the award.

1.2 In order to promote an outstanding or excellent academic performance, excellence in a given course of the program, excellence in research, social service, games and sports, cultural activities, participation in students counselling, participation and constructive leadership, all-round overall performance, the Institute may award various scholarships, prizes, medals and awards either from its own funds or from funds obtained from other governmental or non-governmental sources.

- 1.3 In order to promote the study at the postgraduate level, the Institute may award various scholarships/assistantships to its students either from its own funds or from funds obtained from other governmental or non-governmental sources.
- 1.4 In order to promote research and development in a specified field, the Institute may award various scholarships, prizes and medals to its undergraduate as well as postgraduate students either from its own funds or from funds obtained from other governmental or non-governmental sources

2. FINANCIAL ASSISTANCE FROM INSTITUTE FUNDS

- In order to financially assist meritorious students coming from economically weaker background, the Institute may award Merit scholarships to needy students from its own funds made available by the College Management for this purpose.
- The amount of Merit Scholarship for both general as well as SC/ST category of students shall be as prescribed from time to time by the Ministry of College Management, and approved by the Governing Body.
- A student holding any other scholarship from any other source shall not be eligible to apply for the Merit Scholarship unless the same is surrendered.

3. ELIGIBITY CRITERIA OF MERIT SCHOLARSHIP

Category 1: Award of Merit Scholarship is based on the EAMCET Rank of Students whose ranks below 25,000, The amount will be varied based on Category of rank between 1-25,000.

Category 2: Students who are from financially weaker section and have performed well in the examinations shall be eligible for scholarship. Those who have score above 90% (or) 9.5 CGPA in their final exam to become eligible under scholarship policy. The yearly income of the parents from all sources should be less than Rs.2 Lakh Rupees.

4. INSTITUTE MEDALS AND PRIZES

4.1 BEST STUDENT AWARDS

a) The Institute gives a cash prize of Rs 8,000/- and a certificate to the I Topper and a cash prize of Rs5,000/- along with the certificate for the II Topper from the outgoing B.Tech student batch of every department.

- b) The institute Reimburse the amount for the book purchased by student who is class
 I & II topper in every semester
- c) The institute gives a cash prize of Rs 5,000/- and a certificate to girls topper in every year for all departments.

5. GENERAL GUIDELINES

- All scholarships, medals, etc. are liable to forfeiture/withdrawal partially or fully in case of misconduct or deliberate concealment of material facts by the award winner. A similar action may also be taken if it is found that a student has deliberately misguided the Governing Body with regard to Scholarships, Prizes and Awards by giving false information.
- 2. A student leaving the Institute on his/her own accord without completing the prescribed program of study may be required to refund the amount of scholarship received by him/her in that academic year.
- 3. A student may normally receive only one scholarship/stipend. In case he/she is awarded more than one scholarship/stipend from any outside source, he/she shall be given the option to choose one scholarship or stipend from various alternatives and surrender the other.
- 4. No scholarships will be paid for the month subsequent to the one in which the student completes the examination of all prescribed courses.
- 5. The Governing Body is empowered to change the clauses of this manual by giving an advanced notice to this effect to its member
