

While enquiring into the incident Mr. Lodagala Ashok Babu (17A31A03E2) it is confirmed from Mr. N.Subhash (17A31A0398) about why Mr. Maddi Mohan Kalyan (17A31A03E4) has laken away by some unknown persons in car to nearby Ramesampeta village and bet him and he wanted to know what is the matter. For this, Mr. N.Subhash (17A31A0398) has keeping grudge on Mr. Lodagala Ashok Babu (17A31A03E2) and planned to beat him on our campus bus area, with support of other students intentionally While enquiring Mr. Lodagala Ashok Babu (17A31A03E2) had no issue earlier with him.
